5) Approval of the February 6, 2021 Agenda Kelly Krohn made a **Motion** to approve the agenda with a second from Kathy Melvin, **Motion** passed.

6) Approval of the January 9, 2020 Minutes- Kelly Krohn made a **Motion** to approve the minutes, with a second from Robin Kelley. **Motion** passed.

7) Treasurer's Report- Robin Kelley- The treasurer reported receipt of \$100.77 refund for Zoom with a .26 refund from the bank as funds this month with a current bank balance of \$30,641.72.

Eileen Strangfeld stated two more people are interested in helping with the Trestle Trail clean-up. She also asked if there were any more funds allocated in the budget for new signs for the Trestle Trail. States needs an entirely new sign.

Mark Almer states he made the last route sign for the trail.

Robin Kelley advised there are funds available. Mark Almer and Phill Dayton volunteered to make a new sign.

Due to the pandemic, the Council is unable to have a get together at this time. Mary Lou Brown was a founding member of the Grizzly Flats Fire Safe Council and Council Chair for a year in 2004.

Steve Frazier states to remember to keep a clear path to propane tanks and Fire Hydrants.

Phill Dayton stated there are a many new residents to the community. Need an education campaign going for these residents. Also stated should contact Real Estate agents to give them information regarding Grizzly Flats Fire Safe Council.

Mark Almer stated we already have plans regarding this such as a fundraising flyer. Deb Gregory stated this flyer will be posted in an upcoming newsletter after approval as well as the Facebook page and on other neighboring Facebook pages.

Kara Garrett stated they have an Emergency Response Workshop scheduled for Saturday, March 20th. All the local Fire Safe Councils are invited. Also, multiple agencies are invited as well such as CHP, CalFire, OES, SKLAR, JPA. Currently scheduled for 10am to 12pm but may add another hour depending on how many agencies respond.

Received the map showing where the signs are located for the routes out of the Community. Kara states she will be creating a brochure that includes the map and putting out to the public soon.

E. <u>Sheriff</u> – John D'Agostini/Jack Kerruish

Todd Crawford stated OES has been open and running the Covid response for the County. All the testing, vaccines and policies are coming through the Emergency Evacuation Center. Stated due to the lack of vaccine at this time it is still only available for age 75 and older in this County. Have staff and capabilities in place for a large-scale vaccination program when supply is available.

Stated there is a projected start date for the Bucks Bar bridge replacement of possibly April of 2022. They have begun making an evacuation plan while the project is in progress as it will continue through the summer months.

F. <u>El Dorado County Fire Safe Council</u> - Ernie Lory

Ernie states the El Dorado County Fire Safe Council had a meeting on January 20th

The County wide CWPP should be receiving a draft of it by the end of this quarter for our comment. CalFire and the Fire districts should be receiving it in the second quarter, By the 3rd quarter the Board of Supervisors and other departments should receive it for their comments.

CalFire has put together the fire history and maps of the El Dorado County area and this will become part of the CWPP.

CalFire target inspection areas this year in no specific order: Cameron Park Starkes Grade and Sly Park Road Sand Ridge Motherlode and Highway 49 and the China Hill area Gold Hill and Lotus Road Highway 49 in the Cool area Meyer's South of Highway 50 Advised the county will be doing 450 parcels this year for Vegetation management inspections starting in April. There are two major areas anticipated: Deer Valley/Rescue area as well as Pleasant Valley Road/Hanks Exchange area.

The County is developing an outline for a Five-Year Risk plan for the County.

G. <u>California Highway Patrol</u> – Public Information Officer - Andrew Brown The California Highway Patrol cars are getting new light bars which include a High/Low Siren. States all new CHP vehicles are equipped with them.

When CHP or Law enforcement plays a High/Low tone in the neighborhood "it's time to go" This is only played for evacuations purposes.

States when riding a motorcycle there are 3 important things to remember, Need an M1 License, a Motorcycle helmet and the motorcycle needs to be licensed/registered.

States there are also California Motorcycle Safety Programs open all over the State.
