B. <u>Pioneer Fire Protection District</u> –PFPD Fire Marshal Ken Earle/Chief Whitt Chief Whitt introduced himself to the Council.

He stated that statewide the Forest Service is having a hard time hiring.

He reported they are eliminating the QRT name, changing it to Volunteer fire fighter. He stated that they need volunteers.

The Chief reported that there will never be a full time Staff in Grizzly Flats.

Deputy Sheriff Greg Almos reported that they will be switching mass notification platforms from the Code Red system to RAVE (Mobile Alert Emergency Notification System). He reported that everyone who is in Code Red will be transferred over to RAVE. If there is a need to use mass notification in the meantime both systems will be utilized. He reported they are expecting a dry and busy season.

The Pollock Pines Fire Safe Council will disband unless a new Chairperson is found. The El Dorado County Fair will be held June 16-19th. The El Dorado County Fire Safe Council will be one of 5 agencies staffing a booth.

The Bureau of Land Management is locally fully staffed and has over 900 parcels of land in this area they are managing.

K. Long Term Recovery Group - Jennifer Hibbard

Jennifer reported Bill Roby is no longer the Chair as he is very busy with other projects. She stated Amy Medford has stepped up to be a 3rd Co-Chair.

She reported they are looking to hire someone as a Construction Committee Chair. They need to have had a Contractor's license at some point. They will be having a 1 year celebration event. This will be August 13th, a Saturday at Pioneer Park.

Mark Almer reported that the Grizzly Flats Community Award will be given out at the 1 year event. This year the recipient of the award will be decided by the Executive Board.

There will be a Music in the Park event on June 26th at Pioneer Park that all proceeds will go back to fund Caldor Survivors immediate needs.

She stated there is a distribution event on June 12th from 12pm-1pm for people who have lost 50% or more of their homes or from 1-2pm for all others.

She reported on June 18th there will be a Fill the Boot event at the 4 corners.

The Council agreed to the purchase of a new "feather style" RED FLAG WARNING sign after discussion. This item was not agendized as it was under the \$300 limit for Council approval, but Mark requested Council concurrence. Mark stated we have gotten approval from Department of Transportation to place the sign where the old "Grizzly Park" sign was on String Canyon and they will put up the post, GFFSC just needs to install the sign. The sign will be on the production floor this week.

- B. <u>Defensible Space</u> Robin Kelley/Liz Lawless/David Manske
 Robin reported the committee met recently and they will be organizing a
 community wide chipping day, possibly August 1st. Everyone will need to preregister. The committee will be creating signage.
 She stated they have a Veteran that needs to have his property raked in order to
 have his property qualify for the County Veterans process.
- C. <u>Grants</u> Ernie Lory/Kelly Krohn/David Manske Mark Almer read a report from Ernie Lory-

Our CCI investment Grant may have been denied. This was for fuel reduction south and west of Units 8 & 9 and Woodpecker acres.

The Henry's Diggings/GF 18 project now has a signed contract with Eco Forest Management.

The Caldor Grizzly Flats Recovery and Reforestation project will be sending ROE applications out. Recover and reforestation will be on non-industrial lands such as SPI and others. US Forest Service funds will be for a 300 foot fuel reduction along their boundary on both sides, 150 feet on private property, and 150 feet on federal land starting on the northeast corner, down the east side of the Community and

working around to the south side of the Community.
