Minutes- April 2, 2022, 9:30 a.m.-Meeting at Leoni Meadows

1) Call to order at 9:45am. There was not a quorum of the membership until approximately 1030 a.m. so all items involving "discussion/action" were deferred until a quorum was established.

5) Approval of the April 2, 2022, Agenda Robin Kelley made a motion to approve the agenda with a second from Liz Lawless, the motion passed.

A) Special Presentation

<u>Presentation by Mark Egbert-Resource Conservation District-</u>CCI grant application Caldor Grizzly Flats Recovery Phase 1 and the Caldor Fire Recovery and Reforestation project

Presentation led by Ernie Lory in Mark Egberts absence. Mark Egbert has pulled together an emergency reforestation team to do projects for private landowners. This is a combination of funds available to start with. The team of 8 registered professional foresters have already been hired.

There are several steps to this process. The Grizzly Flats Fire Safe Council's portion of the work is to gather interested parties to join this project

To sign up for this program, landowners would need to fill out an additional ROE that is separate from the one signed with the county due to the Caldor Fire.

This will include burned, bark beetle trees, brush and slash. The land will then be prepared for reforestation.

There would be no cost to the homeowners.

Deputy Sheriff Baer

Deputy Baer reported that they have received funds from the State to update the evacuation system from Code Red to the RADE Mobile Alert System which is a smart mobile app system. They are still currently using Code Red until all information is transferred.

He stated that they are putting in for a grant to hire a consultant to rewrite the Hazard Mitigation plan which is due March 24.

## F. <u>El Dorado County Fire Safe Council</u> - Ernie Lory

Ernie reported the El Dorado County Fire Safe Council held a meeting on March 16<sup>th</sup>. He stated the Defensible Space Assistance Program was opened on March 17<sup>th</sup> and within 7 days they had received all the applications in which they had funds to cover. He reported the chipping program is still open and free to homeowners. Ernie stated a Wildfire Resiliency and Vegetation Management group has been created. This program will include a County office of Wildfire Resilience. He also reported that on April 23<sup>rd</sup> there will be a Defensible Space and home hardening training at the Fireman's Memorial Hall in Diamond Springs. The date to be

# G. California Highway Patrol – Public Information Officer - Andrew Brown

Andrew reported that April is Distracted Driver Awareness month.

He stated 3000 to 4000 people reportedly die every year due to distracted driving. They believe these numbers are lower than the actual numbers.

He stated Teslas always record audio and video while on and can be used as evidence.

He stated to be patient when driving behind the large trucks from Grizzly Flats to Mount Aukum. There is no legal/safe place for them to pull over in these areas.

Andrew also reported 11,000 people die every year and someone is injured every 2 to 3 seconds due to DUI.

He reported the Highway Patrol is recruiting now. He stated this is a great career with great benefits.

H. <u>USFS</u> - District Ranger Scot Rogers/Rick Hopson Not Present

I <u>Amador El Dorado Unit Cal Fire</u> - Public Information Officer- Diana Swart and Battalion Chief Josh Vickers

Diana reported gearing up for safety fairs and fire prevention events. May is Fire Prevention and Fire Safety Awareness month.

She stated that the Cameron Park CSD funded a 6 week Fire Fighter Acadamy that just completed. Twenty-five individuals graduated and they secured 15 jobs from that group.

Josh reported they have identified 15 Vegetation Management Projects (VMP's) fuel reduction projects currently. They had prepared to burn some of these but due to weather have not been able to burn them yet.

He stated they are only allowed to clear areas in the State protection areas. Josh reported that Grizzly Flats CCI grant application has been put as a top priority for extending the clearing on the Western side of the Community. Josh gave a report on the Caldor Fire and a timeline of events that occured starting from when he responded.

Shiela stated UC Extension is doing a prescribed burn symposium on April 23<sup>rd</sup>. She reported that Omo Ranch is working with SPI on a repair of an old metal water tank that has been damaged and has no roof. The proposal is for SPI to pay for the repairs and Omo Ranch to design the roof and a way to collect water in an area that has no other water resource. They are waiting for a response from SPI.

Their Firewise committee did a drive around their community with Richard Harris and was very surprising how inaccessible it is to get through on some of the back roads due to the overgrowth.

She requested that the Grizzly Flats Fire Safe Council share their yearly calendar with Mt Aukum and Omo Ranch.

D. Loan of Title III Funding- Robin Kelley Discussion/Action item Robin detailed a proposal for the GFFSC loaning Title 3 funding to neighboring FSC's (Aukum Fairplay, Omo Ranch, Sand Ridge and Oak Hill). Robin Kelley made a motion that Grizzly Flats Fire Safe Council establish a loan process which they may loan funds to other FSC's in South County to assist them in funding Title 3 expenditures. The GFFSC will not have more than \$6000 out in loans at any one time. A loan agreement will require that a loan recipient will request their Title 3 funding reimbursement from the EDCFSC within 5 days of the date of purchase of approved items, and that the loan recipient shall then reimburse the GFFSC within 5 days of receiving those funds from the EDCFSC. With a second from Ernie, the motion passed unanimously.
